Thank you for your interest in the 2019 Holistic Hemp Festival. As a potential food vendor, please be aware of the following information:

1. The fee for a parking space to fit one truck. A \$50 fee will be charged for electricity if required by vendor.
2. In keeping with the theme of the festival please provide one sale item made with Hemp to the public. If you have any question on where to buy or how to use Hemp call or text Danielle at 412-519-4566 or Doug 304-281-3183 (i.e. ice cream can be topped with chocolate covered hemp seed, any baking item cake, cookies can use hemp flour in place of some reg. flour)
3. Applications are reviewed individually based on need and written description of food products to be served.
4. Health Permit – You will be required to apply for a temporary health permit in advance. Heres a [link](#) to the permit. The Health Department staff will check all food booths; if you do not have a Health Permit they will shut you down.
5. Food Trucks and Vendors will be provided spaces based upon their order of arrival. Food trucks and Vendors must plan on being there for the entirety of the event.
6. The event will be held rain or shine.
7. Absolutely No Vehicles of any kind in the Grassy area.
8. Post all prices for items at your food truck or vendor space.
9. Please keep your area clean and throw trash in bins or dumpster provided.
10. No alcohol of any kind will be sold or consumed at the event.
11. Operating License and Insurance: Food trucks must provide the Holistic Hemp Festival with a copy of their Operating License and insurance no later than 1 week prior to the event.
12. **HOLD HARMLESS AND RELEASE:** In consideration of participation in any event on property, I hereby release and forever discharge the town, its officers, agents, employees and representatives, and their respective heirs, successors and assigns, from any and all actions, causes of action, suits, proceedings, debt, dues contracts, judgments, damages, claims, and or demands whatsoever in law or equity that the undersigned, its successors or assigns, ever had, now have, or may have in the future in connection with the undersigned's participation in any event on Town property.
